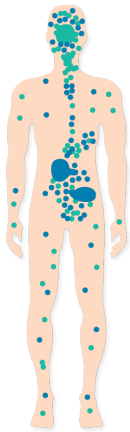
Discovered in the early 1990's, the Endocannabinoid System (ECS) has been identified as the body's natural way to help you achieve balance for optimal function.

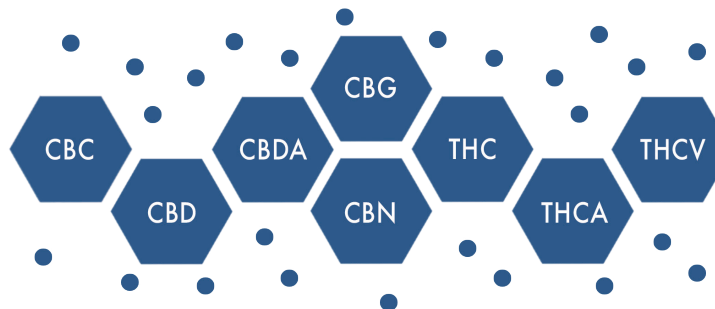

FULL SPECTRUM vs **CBD ISOLATE**

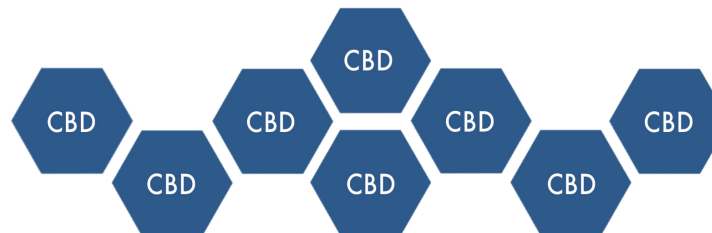
There are different cannabinoid spectrum options to choose from, such as full-spectrum and **isolate**. While different types of **CBD** products may sound similar, there are significant differences.
